(2.39) To provide free legal, medical and socio-economic help/assistance to the poor and needy persons.

(2.40) To draw, accept, endorse, cheques, bills, drafts, notes and other negotiable instruments and to open and operate any bank accounts in the name of the Trust with any bank or bankers.

- (3.2) In the event of vacancy in the office of the Chairman, the board shall elect a Chairman from amongst themselves subjected to approve of the SETTLER.
- (3.3) If any of the trustee die, or desire to retire, refuse or become incapacitated to act as a trustee, then and in every such case there shall be vacancy in the Board.

(4.20) The Board of Trustees shall have power to take decision for opening of account in the name of the Trust. Trustees and/orientations projects, centre run/conducted by the Trust with a Nationalized/Scheduled/ Gramin/ Private Bank or Government Post Office and to operate such account and to give instructions to the Bank/ Post Office and to provide for opening and operation for such account by one or more of the Trustee separately or jointly on by any agent/ representative staff appointed by the Board.
